Student information required

Our new way of working means we require the following limited student information; full name and date of birth.

Compliant with data protection laws

We understand that you may have questions relating to the transfer of this information and data protection legislation. Endsleigh will supply a Data Sharing Agreement that conforms to this legislation.

Endsleigh will not use your student information for marketing purposes.

Secure transfer and storage of student information

Access to data is only granted to users who require it for a legitimate business purpose. Networks housing the data are protected by firewalls and intrusion detection systems. Data is stored and processed subject to information security and data protection policies.

Endsleigh can accept student information via secure email or we can arrange for information to be sent via an alternative file transfer mechanism.

Frequently asked questions

What is the purpose of sharing student information?

This enables Endsleigh to improve claims validation, simplifying and speeding up the claims process for your students, reducing the time and effort required to make the claim and enabling real time validation in the event a student requires the use of the counselling helpline. In addition it will mean that we can provide a more personalised service when a student contacts Endsleigh directly as we will know they are one of your members.

Do I need to obtain consent and how should I communicate this to our members?

You do not have to ask consent where data is required for fulfilment of a contract which is the case here. However, you do need to make students aware that the way you are using their data has changed. We understand this will be easier for you to do when memberships renew and therefore do not require data to be sent to us until later in the year.

Can the individual student control elements of the processing or object to it?

The student will have the right for their information to be deleted at any time. The method of sharing student information with Endsleigh should be clearly stated within the partner's privacy policy. Endsleigh's privacy policy is referenced through multiple sources including our policy documentation and instructions of how to apply for data records to be deleted are detailed within the notice.
